

Mid Market Rent Registration Form

National Housing Trust properties at The Glen, Coalsnaughton (Dunmoss View & Nechtan Drive)

Mid-market rent properties are intended to assist households that have incomes above the average levels of tenants in social rented housing (Council and Housing Association homes) in Clackmannanshire.

The properties which you are registering for are let on behalf of a private landlord, Coalsnaughton 2012 NHT LLP. Applications will be prioritised to persons within the Priority Client Groups and who meet relevant affordability checks. If allocated a property and you are still in occupation of the house after, at least 5 years, you may have the opportunity to purchase the property.

Priority Client Groups

When these properties are allocated, priority will be given to persons who meet the following conditions:

- Council or Housing Association tenants
- Persons who have a current registration on the Clackmannanshire Common Housing Register
- Households who are small, newly forming households who cannot afford to buy or larger households who are currently overcrowded and cannot afford to buy or rent privately
- Households with an gross annual “earned” income not exceeding £29,000 for a single adult household and not exceeding £37,000 for a two-adult household.

Please submit verification of income (previous 3 months) and Photographic identification (copy of driving licence or passport) along with your registration form.

Anyone over the age of 16 can register.

If your first language is not English, we can arrange for the form and guidance to be translated.

If a question does not apply to you, please score it through or write “n/a”- so we know that you have not missed it out

Please complete the form carefully. The information you give us will allow us to assess if you are eligible for the scheme. We can provide copies in larger print if necessary.
